Procedure

- 1. Mix part A colors at room temperature to ensure uniformity. Set aside.
- 2. Set a hot plate to 75°C.
- 3. Melt all ingredients in part B in a separate beaker on the hot plate. Blend the mixture by hand.
- 4. Stop heating.

- 5. Add part C to part B and mix.
- **6.** Add part A. Mix to a uniform color.
- 7. Add part D. Stir slowly to get rid of any air bubbles.
- 8. Fill a lipstick mold with the mixture, then freeze at -7°C for 10 minutes.
- 9. Transfer the finished lipstick into a case.
