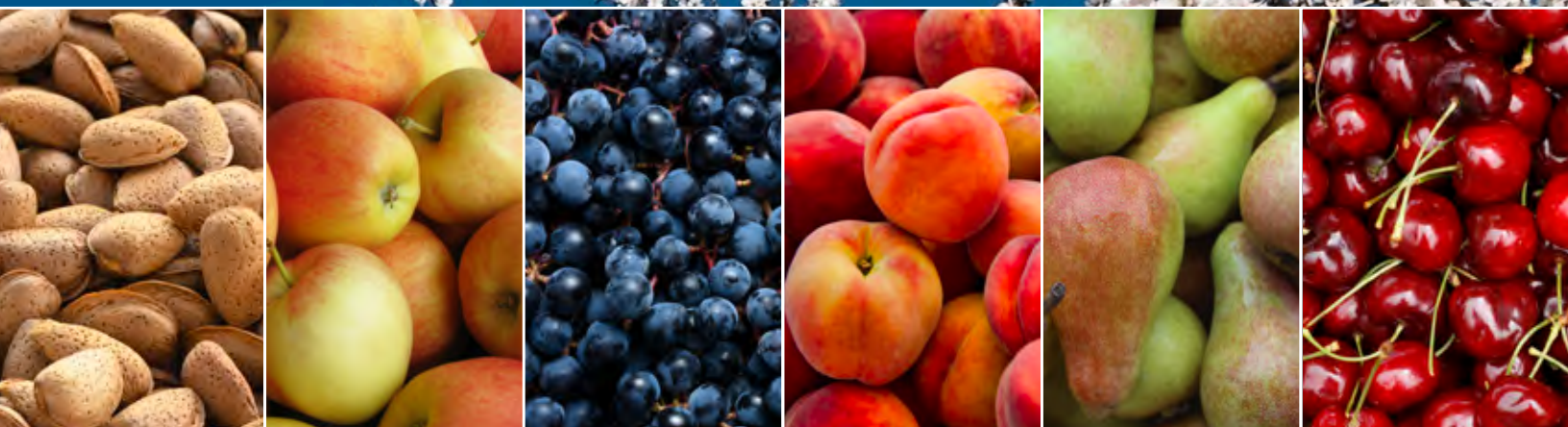

## Mode of action

Ziram Granuflo is a multisite fungicide (group M3) that inhibits spore germination and mycelium growth by interfering with various enzymes involved in the respiration process. Its ability to act on many sites of the biochemical process ensures that Ziram Granuflo remains at low risk for resistance development and retains its efficacy against many fungi.

## Resistance management

- Tank mix a multisite fungicide with a single-site, mode-of-action fungicide.
- Apply multisite fungicides alone when disease pressure is low.
- Rotate between modes of action.

The water-dispersible granules (WDG) processing technique was developed by Taminco and registered under the trade name Granuflo. This high-quality formulation is virtually dust-free and disperses quickly in the spray tank. It doesn't clog nozzles and is not affected by freezing temperatures.
