## Recognizing superior suppliers

Annually, Eastman recognizes suppliers that have performed above and beyond the expectations we have set through the Eastman Supplier Excellence Program.

#### **Excellence Award**

Given to suppliers who meet on-time delivery, conform to order specification, and prove continual improvement through significant, documented value-add projects.



#### **Improvement Award**

Given to suppliers who have made significant and steady improvement to meet on-time delivery and order specification. In this category, stakeholders agree the supplier has strong potential to reach "Excellence" level in the future.

#### **Innovation Award**

Given to suppliers who have demonstrated a significant innovation which adds major value to Eastman. This could include a new technology, new or improved process, or a value-adding project.

#### **Sustainability Award**

Given to suppliers who have demonstrated significant and new improvements for Eastman in one or more of the following areas: waste and recycling; natural resources and/or material content; and energy and emission.

The Eastman Supplier Excellence Program evaluates suppliers based on the following criteria:

- Delivery
- Terms of sale
- Supplier compliance
- Quality of material or service
- Business relationship status
- Flexibility and responsiveness
- Innovation
- Market knowledge
- Safety and security
